



# NEW EMPLOYEE PHARMACY \$340B REPORT

In February, 2024, Sweetwater Hospital Association (SHA) opened the Employee Pharmacy after receiving approval to participate in the 340B Drug Pricing Program. This program is a federal program that was started in 1992 to negate the rising cost of drugs. The 340B program allows rural hospitals, such as Sweetwater Hospital Association that serve a large population of uninsured patients, to purchase outpatient medications from participating pharmaceutical manufactures at prices that have been discounted. The 340B program generates valuable savings for eligible hospitals that meet the criteria to participate in the program.

In 2021, SHA began focusing on the government framework and learning the nuances involved in this complex prescription pricing program. As with everything, COVID-19 stalled the program for more than a year, but SHA pressed forward in continuing the vision. On July 1, 2023, the vision turned into reality when SHA was granted Covered Entity status with the 340B Drug Pricing Program. This savings will allow SHA to provide more services to those in our community, minimizing the need to travel outside Monroe County.

As well as benefiting the community, the 340B drug pricing program allowed SHA to open a new employee pharmacy. This employee pharmacy benefits current and future employees, as well as their families, that are seen by SHA providers. Employees and their families will have quick access to discounted medications for prescriptions that are written by their SHA provider and filled by in-house pharmacists.

**340B Fun Fact**: According to the American Hospital Association, "In 2019 alone, 340B hospitals provided nearly \$68 billion in community benefits. At the same time, total 340B sales were approximately \$30 billion, of which hospitals accounted for approximately 85% or \$26 billion. That means for every dollar in 340B sales, 340B hospitals provided over two dollars in benefit to the patients and communities they served."





In 2023, Sweetwater Hospital Association partnered with StatCare Pulmonary and Sleep Medicine to enhance our patient's care. This partnership allows SHA to advance our patient's medical outcomes by working with the medical community to expand patient services. Communication with primary care physicians and specialists also allows patients to easily bridge their services to allow for best continuum individualized care. In today's healthcare environment, StatCare Pulmonary provides the best innovative programs by focusing on superior standards of practice and service excellence through quality patient care. Sweetwater Hospital Association continues to focus on partnerships that allow your health to always be our mission.

# **SHA WOUND CARE CLINIC**

In 2024, Sweetwater Hospital Association Wound Care Clinic located at 304 Wright Street in Sweetwater, TN in POB-B on the third floor opened their doors to offer advanced wound care for people living with chronic, non-healing wounds. Sweetwater Hospital Association has partnered

with Healogics, the nation's leading provider of advanced, chronic wound care services. It is estimated that chronic wounds affect 6.7 million people in the U.S. and that number is rising, fueled by an aging population and increasing rates of conditions such as diabetes, obesity, and the late effects of radiation therapy. If left untreated, chronic wounds can lead to diminished quality of life and possibly amputation of the affected limb.

Sweetwater Hospital Association offers an evidence-based, systematic approach to advanced wound care. A patient's individualized



treatment plan may include specialized wound dressings, debridement, compression therapy, advanced cellular products and topical growth factors, edema management and/or non-invasive vascular assessment. These treatments are the result of a team approach between the clinics's physicians, nurses, and the referring physician. A treatment plan is developed and scheduled based on the patient's needs. Once treatment is complete, the patient will return to their primary physician to continue routine care. Additionally, Sweetwater Hospital Association Wound Care Clinic is be equipped with Healogics newest

technologies: Clinical Optimization and Decision Support These applications on Healogics' WoundSuite platform, enable the critical connection between people living with chronic wounds and their multi-disciplinary healthcare team for collaborative, evidence-based, patient-centered care.

Likely candidates for treatment at the clinic are those suffering from diabetic ulcers, pressure ulcers, infections, compromised skin grafts and flaps, and wounds that haven't healed within a reasonable time frame. People with wounds that have not improved with traditional methods of treatment may benefit from a visit to Sweetwater Hospital Association Wound Care Clinic. No referral is needed, so call today 865-213-8759.





### **ADVANCEMENT IN SURGERY**

Sweetwater Hospital Association (SHA) proudly announces the recent investment of three New Stryker 1688 Advanced Imaging Modalities(AIM) 4K Platforms. The 1688 AIM 4K Platform is a surgical tower that will provide their surgeons with superior visualization and advanced imaging modalities across an array of surgical specialties.

The new all-in-one system features:

- 4K image resolution offering surgeons crystal-clear images for improved surgical visualization.
- L11 Light Source and Auto Light Technology: The proprietary auto light technology automatically adjusts based on anatomy to provide consistent lighting, enabling our surgeons to focus on the procedure at hand.
- Advanced Imaging Modalities: Three distinct SPY fluorescence imaging modalities, Contrast, Overlay, and ENV, are integrated into the platform and enable real-time 4K fluorescence images of perfusion and critical anatomy.

These advanced tools have been shown to significantly improve patient outcomes, particularly in colorectal, laparoscopic cholecystectomy, and other minimally invasive procedures. SHA continues to provide access to high quality and safe surgical procedures close to home.

### SHA Installs a New Clinical Laboratory Coagulation Analyzer

Sweetwater Hospital Association is pleased to announce the recent purchase and installation of a new clinical laboratory coagulation analyzer, the ACL TOP 350. This is a compact instrument that creates a breakthrough in hemostasis testing, offering the most advanced automation and quality management for routine to specialty assays. This instrument provides superior performance across the entire testing process, including automated pre-analytical sample integrity checks, advanced quality and accreditation support, and an enhanced system security, which ensures quality results and lab efficiency. This results in a very accurate and timely assessment of our patient's blood



coagulation state, enhancing the diagnostic ability for preventing and/or treating coagulation disorders. The recent purchase of this instrument, and the subsequent training of our laboratory personnel provides for minimized interruption of service during routine maintenance, and knowledgeable personnel able to analyze samples and troubleshoot any unforeseen issues.

# New CT Scanner at SHA Increases Opportunities

This year, Sweetwater Hospital Association (SHA) expanded our Radiology Department clinical capability and




enhanced productivity by adding the Cannon, Aquilion Prime-SP Computed Tomography (CT) scanner. We can aid in fast and confident results by offering patients better technology and an innovative approach to CT reconstruction that uses deep learning technology. The Aquilion Prime-SP reduces noise, creating a sharper image. The CT scanner has been trained to boost signal to deliver sharp, clear, and distinct images across many body regions, including the brain, lung, cardiac, bones, and body areas. The Aquilion Prime-SP also offers power-assisted patient positioning. The power-assisted patient positioning allows SHA to expedite the setup of patients while

reducing the heavy lifting required by the attending care team. The Aquilion Prime-SP CT scanner increases productivity and lowers cost while enhancing diagnostic performance at SHA.

### **SHA Accutech Security System**

Sweetwater Hospital Association (SHA) knows that every baby needs to be safe, and secure. In March 2024, Sweetwater Hospital Association installed the Cuddles Infant Security System by Accutech.



The Cuddles Infant Security System provides the technology to care for our patients while keeping our facility-protected zones intact in real-time, ensuring that SHA babies are safe and not compromised. This system has a check-in every 1.5 seconds and alarms after 15 seconds of a missing check-in. even during a network failure. The soft ankle band fits a baby of any size. SHA patients are in the best hands with caring nurses, skilled doctors, attentive hospital staff, and advanced security technology.


